8. Applications for a Voter Authority Certificate or an Anonymous Elector's Document valid for this election must reach the Electoral Registration Officer by 5pm on 25 April 2023. 9. Applications to vote by proxy must be received by the Electoral Registration Officer at the address shown below by 5pm on 25 April 2023.
