Minutes of a meeting of Christchurch Parish Council on Monday 8 May 2017 at Christchurch Community Centre, Upwell Road, Christchurch at 7.30pm

- 002/17-18 Confirmation of Minutes**
Minutes of the meeting held on 10 April 2017 were correctly recorded and sign as being a true record.
- 003/17-18 Public Time**

- Disappointment was expressed at the lack of public transport in the village. Cllr Beswick tried to find a solution but lacked support from the village. Too few people would use it, so it wasn't cost effective to run. Cllr Sutton expressed disappointment that villagers do not support things – citing the shop. If the village doesn't grow, it will die. Everyone agreed that young people need to be more involved in the Parish Council etc – but uncertain how to achieve.
- 004/17-18 Outstanding Matters**
- Hedges and Trees – Church Road has been cleared. Thanks to the Parish Councillors and Mattie who helped clear the dyke on the recreation ground. Further dredging will need to be done in the autumn when the adjacent field is clear of crops.
 - Signs – Costings as follows: £1157.19 to move the viillage sign on Upwell Road; supply and erect Christchurch sign on Padgetts Road and Community Centre sign £1479.54. Parish Council feels this is very expensive. Review again in 3 months when we have more of an idea how the budget is going.
 - Bus Shelter – gardening club do not wish to be involved at present. Cllr Harper will erect some trellis and plant some plants. Cllrs Harper and Russell will concrete the memorial bench into the bus shelter
 - Village dog mess – Street Scene Officer has been to visit the school and Syringa House. Follow up letter will be issued.
 - Planning information following the Appeal Decision for Padgett Road property – Parish Council reviewed the appeal decision points, along with some explanatory notes from Nick Harding, Head of Planning. The Parish Council were interested to note the comments on limiting the building of houses in the village, and the need for villager/Parish Council support for planning permissions to be granted.
