- Rubbish bins recreation ground bins have been repaired by GH and JH. Thanks was expressed for their work
- Defibrillator Parish Council agreed that a defibrillator at the Community Centre was needed. The cost is in the region of £2,000. It was felt that it would be best to raise the money through the village, rather than lottery type funding there have been local pledges already. Fundraising event with CRGC? Cllr Sutton apply for some FDC funding, agreed, clerk to submit form via Cllr Sutton. Request support from villagers in Heron/facebook etc. Donation box at food festival? To be raised at CRGC meeting.
- Bus shelter bench has been installed. Children climbing up the trellis onto the roof. Erect signs? Discuss at next meeting
- LHI/village calming application submitted. Cambridgeshire County Council will now assess and discuss the best resolution options.

Also, FDC have some concern over their compliance with 5 year land supply which may lead to undesired planning applications being passed

087/17-18 Recreation Ground Charity

Clerk gave an overview of recent changes due to Parish Council being sole trustee of the charity. All decisions should be made by the Parish Council. Currently looking into options to ensure the charity can be run by a community led management committee. Parish Council will agree some Terms of Reference for decision making in the meantime. NR confirmed that Ruth Ingram has agreed to deal with admin for the Recreation Ground Charity and its management group.

089/17-18 Correspondence

Parishioner has been in touch to express concern about Upwell Road around West Star Farmhouse and Christchurch Hall and onto Sixteen Foot Bank. It was advised that funding is an ongoing problem. A footpath would be very expensive. A mirror at the Upwell Road/Sixteen Foot Bank is unlikely to be agreed by Cambridgeshire County Council.

The Parish Council agreed with the correspondence but does not have a solution.

Suggests that residence take photos/keep a record of any incidents. JH to add to the overall Village Calming Scheme Thanks was expressed for the correspondence.
