031/18-19 Apologies for Absence

032/18-19 Declarations of Interest

All five members present declared a non-pecuniary interest in relation to their role as Trustees of the Recreation Ground charity in connection with agenda item 038/18-19.

033/18-19 Confirmation of Minutes

Minutes of the meeting held on 11 June were correctly recorded and signed as being a true record.

034/18-19 Public Time

Mr Chappell asked to speak about the forthcoming Local Highway Improvement bid and the Chairman agreed to allow him an opportunity to participate in the discussion under agenda item 039/18-19.

035/18-19 Outstanding Matters

- a) Plaque for Community Centre -has been collected and installed.
- b) Public Space Protection Order awaiting further information from Fenland DC.
- c) Website the domains have been purchased and work is under way on the new website.
- d) Street Pride no response to the initial publicity. A launch event was suggested.
- e) Allotment Tenancy resolved that the tenancy be extended for a further six years @ £150 per acre per year plus drainage rate, with a rent review after three years. Clerk to notify tenant and prepare agreement for signature.
- f) Speed Monitoring Device the community benefit fund from the Coldham Windfarm appears to support only the parish of Elm. The fund is operated by Fenland DC and the Clerk has asked for clarification. It was resolved that an application for £3,250 be submitted to the National Lottery Awards for All to cover the purchase of a device.
- g) The Heron a letter was sent to the Editor of The Heron. No reply has been received.
- Street Lighting the deadline for responding to the proposed service level agreement has been extended to allow time for further negotiations with the parishes making their own arrangements.

037/18-19 County & District Councillors Reports

Cllr Sutton reiterated that he had not been informed about the proposed 15% fee for the District Council included in the street lighting service level agreement.

Surface dressing of Crown Road is scheduled for September or October.

The backlog of potholes and other minor faults has now been cleared.

Overgrown hedges remain a problem on pavements and at road junctions.

038/18-19 Recreation Ground Charity

A productive meeting was held between representatives of the Parish Council and the Community Centre Management Committee to discuss the proposals to clarify the management arrangements through the creation of a new governing document. Members of the Management Committee have expressed concern regarding the transfer of additional liabilities to the charity, in particular for insurance and grounds maintenance. In order to alleviate this burden, it was proposed that the Parish Council offer an annual payment by way of a grant under the provisions of Section 137. A further meeting will take place once the detailed financial arrangements have been clarified.

Resolved in principle that the Parish Council makes an annual payment to the Community Centre Management Committee to offset additional costs being transferred to the charity.

039/18-19 Local Highway Improvements

- a) 2017/18 Tipps End work is finally under way on this scheme.
- b) 2018/19 traffic calming work should commence shortly.
- c) 2019/20. Mr Chappell explained that it had not been possible to secure agreement from all of the councils for the joint bid for barriers on the Sixteen Foot Bank, so he would like to delay this bid until next year.

In the absence of any other scheme, it was resolved that an application be submitted for a speed monitoring device, requiring a contribution of up to £500 from the Parish Council.
