Mr Lansdell reported that the first batch of waste collected by Christchurch Eco had been sent off and would result in a small cash donation to Townley School in due course. Batteries, printer and toner cartridges are now being collected. 086/19-20 Footpath Outside Plot 1, Field Lodge, Upwell Road

The developer has reported that contracts have been exchanged for the sale of the first of two new properties that will provide the funds to complete the footpath. Completion is scheduled for early December, following which a round table meeting will be arranged with all parties to agree a way forward.

Fenland District Council's contractor has indicated that there is a power supply at this location that would facilitate the inclusion of a street light in the new footpath.
