091/19-20 Confirmation of Minutes

092/19-20 Public Time

Mr Hill reported problems with street lights in Church Road in the vicinity of The Croft, leaving a section of the road in darkness. The Clerk offered to investigate.

093/19-20 Matters Outstanding

- a) LHI schemes 2019/20 and 2020/21 - the MVAS sign from the 2019/20 application is due to be delivered before Christmas. Posts are due to be installed shortly. The Forgotten Corner safety barrier application from 2020/21 is being assessed.
- b) Bus shelter improvement project - the first batch of cobbles will be installed in the spring, when the weather improves. Further cobbles will be painted. Plants have been mown or strimmed again, so no further planting will take place until a defined border is created. Further expenditure of up to £200 was agreed for this project.
- c) Ash trees, Green Lane - the County Council's contractor has cut back the shrubs under the ash trees, but removal would be a better option. To be discussed with new Local Highway Officer during forthcoming visit.
- d) Annual report - members viewed a final draft of the document. The Chairman thanked Cllr and Mrs Hughes for preparing the report. Clerk to liaise re printing.
- e) Euximoor Bridge - no further information available. The bridges officer has advised Cllr Sutton that they are considering options.
- f) Hedge near village shop - the hedge has been trimmed, but will require regular attention.

095/19-20 County & District Councillors Reports

Cllr Sutton expressed his gratitude to Mr Guilford for his commitment to the Heron and wished the new team success.

Street Lights were due to be discussed at December's cabinet meeting, but this has been cancelled due to the General Election. He invited the Parish Council to consider a tree replacement policy whereby it commits to planting 2 new trees for every one removed. Members agreed to adopt this idea.

It appears that the Forgotten Corner LHI project will receive only one £15,000 contribution, rather than one per council. Officers previously advised a combined bid to secure sufficient funding. The rules are unclear and meetings are taking place to clarify the situation before the assessment panel meets on 22 January.

The Upwell Charities Dole Distribution took place on Friday. Donations were made to the Heron, the church and the community centre. Cllr Sutton donated his dole money to the community centre to subsidise the forthcoming bookings for Christchurch Eco. Finally, Cllr Sutton wished everybody a merry Christmas.
