105/19-20 **Chairman's Opening Statement**

The Chairman welcomed everybody to the meeting and wished them a Happy New Year. He also thanked all of the Councillors and members of the public who volunteer their time to improve the village.

106/19-20 **Confirmation of Minutes**

Minutes of the meeting held on 9 December 2019 were correctly recorded and signed as being a true record.

Public Time 107/19-20

Ms Nason reported that the Heron was applying for a grant from the Whitemill Environment Fund and asked whether the Council would be willing to offer a letter of support. Members agreed. With 41% of the Heron's costs raised through advertising, there is a need for additional sources of funding.

Mr Lansdell reported that the first Litter Pick had been very successful, with 14 volunteers attending who collected 5 bags of recyclable rubbish and 10 bags of non-recyclable. He will now be working with those volunteers to establish a Street Pride group for the parish. A meeting on 24 February will adopt the constitution and elect the committee in readiness for the Great British Spring Clean event from 20 March to 13 April.

Mr Steenson reported that the Post office van service continued to be unreliable and asked whether it is possible to find out beforehand if it will not be present. The Clerk offered to pursue this again. Clerk Cllr Gladwin reported that the no through road sign at the junction of Crown Drove and Sixteen Foot Bank was missing and vehicles had been attempting to use this during recent road closures in the area. The Clerk will report this.

112/19-20 Christchurch Recreation Ground Charity

The Clerk will present the draft of the new governing document to the charity at their meeting on 29 January. Subject to their approval, the document will be presented to the Council at their next meeting. Cllr Harper reported that he has applied for a grant to install CCTV at the Community Centre and that BT Openreach conducted a preinstallation survey for the wifi and concluded that a new telegraph pole will be required in the car park. A 30-day consultation period is required before this can be installed.

- b) The financial report as at 31 December shows income received of £14,784.03 and expenditure incurred of £34,814.09 leaving a shortfall of £20,030.06 and total funds held of £30,301.50. The grant for the solar panels from the Whitemill Environment Fund was not received in December, but should be in the January account. The contribution of £500 from the Horse Show account has not been received. Cllr Bliss will contact Mr Russell. The allotment rent is outstanding. The Clerk will issue a reminder. Members asked the Clerk to notify the tenant that the tenancy will not be renewed after the termination date.
- c) The Christchurch Craft Club submitted a grant application under Section 137 for £216. Members resolved to support this application as a one-off donation.

116/19-20 Footpath Outside Plot 1, Field Lodge, Upwell Road

The Clerk reported that the developer has appointed a contractor and is negotiating a Section 278 agreement that will require no involvement from the Council. It is hoped that the works will be completed in March.
