121/19-20 Confirmation of Minutes

Minutes of the meeting held on 13 January 2020 were correctly recorded and signed as being a true record.

122/19-20 Public Time

Mr Lansdell reported that the Christchurch Eco initiative continues to expand, with projects under way in three primary schools and two shipments per month being sent for recycling. The first meeting of the new Street Pride group will take place on 24 February. The Chairman congratulated Mr Lansdell on his success so far and thanked him for generating a whole page of Christchurch news in the local paper. A resident reported issues with the overhanging trees in Green Lane making access difficult for farm machinery. The Clerk will discuss this with the Local Highways Officer, prior to writing to the owners of the adjoining properties.

Ms Nason delivered a grant application from The Heron, which will be considered at the next meeting. She expressed her concern that the VE Day Anniversary event at the Community Centre might conflict with a similar event at the Dun Cow and suggested that the two venues work together on a joint celebration.

123/19-20 Matters Outstanding

124/19-20 Police Report

No report received.

125/19-20 County Councillor Report

Cllr French reported that the Council's budget-setting meeting is on 11 February. The budget includes a new fund of £5m for capital grants for community projects covering a wide range of themes. Match funding will be required. There is an additional £6.36m for highways and an extra £200,000 for the Local Highway Improvement scheme. The Council will also invest £15m in decarbonising 69 council-owned buildings. The Council Tax will rise by 1.59% plus an additional 2% for adult social care.

The Innovate & Cultivate Fund is a £1 million fund to help voluntary, community and social enterprise sector organisations realise their projects and ideas that help address the needs of local residents. Projects include Timebanks, Good Neighbour Schemes, Dementia Friendly Communities and Men's Sheds. Mr Lansdell mentioned that there is a large shed at the rear of the Dun Cow and the landlord might be interested in establishing a men's shed. Cllr Harper indicated that improvements planned for the Community Centre might be eligible for funding from the new capital fund.

Cllr Sutton expressed concern that when reporting issues to the Highways authority, he was receiving responses indicating that works would be carried out either within three months or not at all.

129/19-20 Street Lighting

Members considered the letter from Cllr Boden, Leader of Fenland District Council regarding future payments. They suggested that the Town Councils be asked to make a contribution to the revenue costs of their lights sufficient to enable the District Council to offer an equivalent level of funding to the parishes. The Council is still awaiting the condition survey, so has been unable to replace any lights, so responsibility for this could now be handed back to the District Council. Members expressed the view that the revenue costs should be paid by the District Council, as they have been for the last 40 years.
