#### 033/21-22 Public Time

It was reported that the hedge around the former village shop is obstructing the pavement again.

#### 034/21-22 Confirmation of Minutes

Minutes of the meeting held on 14 June 2021 were correctly recorded and signed as being a true record.

# 035/21-22 Matters Outstanding

- a) Bus shelter improvement project no update received.
- b) Green Lane and Recreation Ground trees the Clerk has prepared a specification for the works to obtain quotes from tree surgeons. Members agreed to include the copse adjacent to the Community Centre and the two trees outside the Community Centre in the specification.
- c) Pavement outside Field Lodge, Upwell Road work should commence soon.
- d) Street lights the annual energy, repairs and maintenance bill has been received.
- e) Roadside drains a contractor has jetted the drain outside The Green, Upwell Road, but it appears to be partially blocked. Highways will undertake further work.
- f) Local Highway Improvement applications the Clerk presented further analysis of the last six years of LHI applications in Fenland. He reported that other councils have expressed an interest in being a co-signatory to the letter to the new Leader of the County Council. Members thanked the Clerk for his analysis of the data. The deadline for the next round of applications is 15 September. Members agreed to consider safety features at junctions on the Sixteen Foot Bank. To be agreed at the next meeting.

- h) Benches the Clerk circulated several options for different styles of recycled plastic bench. The Whitemill Environment Fund might be able to consider offering funding to the educational elements of the project. To be considered at the next meeting.
